

Articulation Agreement – Prior Training or Licensure or Certification
Memorandum of Understanding

**Brevard Community College Returning Student with
Current Paramedic Licensure to AS Emergency Medical Services Degree**

Brevard Community College (BCC) will apply postsecondary credit to eligible students who have met the criteria as stated below. *The student will not be charged tuition or fees for the postsecondary credit awarded.*

EFFECTIVE TERM DATE: Spring 2013

Former BCC students who completed the Paramedic program at BCC under a previous catalog and course numbers will be considered to have satisfied the Paramedic portion credits of the AS Emergency Medical Services Degree based on the following:

- Student holds a current **Paramedic license from the National Registry of Emergency Medical Technicians (NREMT) or Florida Department of Health (FDOH)**
- Student completed all Paramedic program requirements at BCC
- Student meets the following criteria:
 - Satisfies all BCC admissions requirements
 - Students entering BCC's Emergency Medical Services AS degree (EMAS) program must have a standard high school diploma or its equivalent, or a CPT-Eligible Certificate of Completion, and must meet the requirements of State Board Rule 6A-10.0315(3), FAC (College preparatory testing, placement, and instruction). Students earning scores less than those listed shall enroll in college preparatory communication and computation instruction.
 - Is currently enrolled in the AS/EMAS degree

To request record update to reflect completion of current Paramedic requirements:

- Student will submit the "Petition for Articulated Credit" form and proof of current Paramedic licensure to the Dean of the Institute of Public Safety
- Form will be forwarded to the Office of the Registrar for record update

Notes:

- **Credit for Emergency Medical Technician (EMT) courses** that are part of the EMAS degree may be awarded based upon an existing Memoranda of Understanding (MOU) to individuals who hold a current EMT Basic certification from NREMT or FDOH. Refer to the MOU for more information.
 - Returning students who completed the EMT program at BCC under a previous catalog and course numbers will be considered to have satisfied the EMT portion of the Emergency Medical Services AS degree
- **To graduate with the AS in Emergency Medical Services**, students must meet all requirements as outlined in the College Catalog, complete at least 25% of the degree through traditional coursework at BCC, apply for graduation and pay applicable graduation fees.

Questions regarding this agreement should be addressed to the Dean of the Institute of Public Safety, the EMAS Curriculum Coordinator/Program Manager, the Office of the Vice President of Academic Affairs, or the College Registrar.
