



# Public Records Exemption Form

Florida Statute 119.071(4) Florida law protects certain personal information for some positions. If you are exempt under Florida Statutes, please check the appropriate box below, sign, date, and forward this form to Human Resources.

**I am a current EFSC employee and I am currently exempt from Public Records requests per Florida Statutes, Chapter 119.071(4), as indicated below:**

- I am currently or have been the spouse or child of Active or Former Law Enforcement Personnel, or of a Correctional Officer or Correctional Probation Officer.
- I am currently or have been the spouse or child of Active or Former Personnel of the Department of Children & Family Services whose duties include the investigation of abuse, neglect, exploitation, fraud, theft, or other criminal activities.
- I am currently or have been the spouse or child of Active or Former Personnel of the Department of Health whose duties are to support the investigation of child abuse or neglect.
- I am currently or have been the spouse or child of Active or Former Personnel of the Department of Revenue or of local governments whose responsibilities include revenue collection and enforcement or child support enforcement.
- I am currently or have been the spouse or child of a Firefighter certified in compliance with s. 633.408, F.S.
- I am currently or have been the spouse or child of a Justice of the Supreme Court or a District Court of Appeal Judge.
- I am currently or have been the spouse or child of a Circuit Court or County Court Judge or a Judge of Compensation Claims.
- I am currently or have been the spouse or child of a Current or Former Judge of U.S. Courts of Appeal, a U.S. District Judge, a U.S. Magistrate, a U.S. Attorney or Assistant U.S. Attorney, a General or Special Magistrate.
- I am currently or have been the spouse or child of a Current or Former State Attorney, Assistant State Attorney, State Prosecutor, or Assistant State Prosecutor.
- I am currently or have been the spouse or child of an Administrative Law Judge of the Department of Administrative Hearing (DOAH).
- I am currently or have been the spouse or child of a Child Support Enforcement Hearing Officer.
- I am currently or have been the spouse or child of a Current or Former human resource, labor relations or employee labor relations director, assistant directors manager, or assistant manager of any local government agency or water management district whose duties include hiring and firing employees, labor contract negotiation, administration or personnel-related duties.
- I am currently or have been the spouse or child of a Current or Former Code Enforcement Officer.
- I am currently or have been the spouse or child of a Current or Former guardians ad litem as defined in s. 39.820, F.S.
- I am currently or have been the spouse or child of a Current or Former juvenile probation officer, juvenile probation supervisor, detention superintendent, assistant detention superintendent, senior juvenile detention officer, juvenile detention officer supervisor, juvenile detention officer, house parent I and II, house parent supervisor, group treatment leader, group treatment leader supervisor, rehabilitation therapist, or social services counselor of the Department of Juvenile Justice.
- I am currently or have been the spouse or child of a Current or Former public defender, assistant public defender, criminal conflict and civil regional counsel, or assistant criminal conflict and civil regional counsel.
- I am currently or have been the spouse or child of a Current or Former employee of the Department of Health whose duties include, or result in, the determination or adjudication of eligibility for social security disability benefits, the investigation or prosecution of complaints filed against health care practitioners, or the inspection of health care practitioners or health care facilities licensed by the Department of Health.
- I am currently or have been the spouse or child of a Current or Former member of the Armed Forces of the United States, a reserve component of the Armed Forces of the United States, or the National Guard, who served after September 11, 2001.
- I am currently or have been the spouse or child of a Current or Former nonsworn investigative employee of the Department of Financial Services whose duties include the investigation of fraud, theft, workers' compensation coverage requirements and compliance, other related criminal activities, or state regulatory requirement violations.
- I am currently or have been the spouse or child of a Current or Former emergency medical technician or paramedic certified under Chapter 401, F.S.
